

## Rules regarding applications for the Pitch Fiesta as part of the Script Fiesta Festival

### 10

1. These rules are intended to unify the ways of presenting ideas for the screenplay by the Pitch Fiesta participants during the 10th edition of Script Fiesta Festival in order to ensure that the copyright to concepts is respected as well as to ensure their safety.

2. In order to ensure the above, the application for Pitch Fiesta events will be processed according to the following rules:

- The screenwriter fills in the registration form with the required information. The link to the form is available at [www.scriptfiesta.pl](http://www.scriptfiesta.pl).
- The screenwriter attaches to the form a link to download a short film (3-5 minutes), presenting themselves and their idea for a film/series. A photo of the author should be attached to the same link. There is no limit for the applications.
- Only files sent via <https://wettransfer.com> or <https://www.filemail.com> will be accepted.
- The film is published for two weeks on the Think Film platform [www.thinkfilm.pl](http://www.thinkfilm.pl) between 4th and 17th April 2022. After this date, the films are removed from the Platform.
- Only the producers who have sent their application and Organizers have access to the place on the platform with published films. Access is secured with an individual password.
- Producers can watch any selected film.
- Each view of the film by the producers is recorded. Within 14 days after the end of the event, the screenwriter will receive information with a list of producers who have seen their video material.
- Contact details of producers and screenwriters will be made available in the Festival's E-catalogue.

3. The idea/concept presented in the films is the property of the respective author. It is forbidden to copy, steal or imitate the idea in any way.
